Regular Meeting – July 13, 2016

Meeting called to order at 12:00 p.m. by President Aaron Dienger. After introductions and buffet lunch, the regular meeting commenced. Rebecca Rieber of Lakeview Healthcare Center updated the membership on the construction status, timelines to move patients to the new site, and changes with the facility.

Minutes and Treasurer's Report

Secretary Teresa Schnitzler's minutes of the June meeting were distributed, and Treasurer Patty Gjertsen's Association bank balance report was distributed. The Association bank balance is \$4,606.55. Celebrate West Salem bank balance is \$1,129.97, flowerpot account balance is \$2,789.84, and Winter Wonderland balance is \$12.57 after expenses. There are currently 92 paid members. Ms. Gjertsen reported expenses incurred for the flower project include weekend watering of \$292.50 and the

preparation of the flowerpots billing from Cottage Grove in the amount of \$990.00.


The Association will bid and purchase a hog to raffle at the annual golf outing.

The Village of West Salem, incorporated in 1851, has spent significant time and money providing public infrastructure and public services to its residents. West Salem provides the following services and programs to its residents:



A full-time Police Chief and police department provide law enforcement coverage, educational services, and public relations on behalf of the Village of West Salem. In addition, the Village sponsors and funds a School Liaison Police Officer and Adult Crossing Guards to the West Salem School District.

The entire community is served by public water system (operated by three state-certified operators), including three wells, an iron filter plant, and ground level steel storage reservoir with a 750,000-gallon

capacity. Construction of a second 750,000-gallon reservoir is in progress at the far east end of East Garland Street. A contact stabilization type activated sludge wastewater treatment facility was completed in October of 1999. The Village currently has four state-certified operators.

The West Salem Public Works Department, under the direction of a working, full time public works director, provides a wide array of public services to the community, including, but not limited to: Alley, street, curb and gutter maintenance and repairs; sidewalk maintenance and repairs; regular large article and appliance pickup; snow and ice removal; weed cutting; tree and stump removal; municipal buildings upkeep; parking facilities maintenance; park and shelter maintenance; maintenance and repair of municipal trucks and equipment; assist water and sewer departments in repair and maintenance projects; installation of traffic control devices and striping; street cleaning; and storm sewer and drainage system maintenance.

West Salem also provides a wide array of recreation activities and programs for all ages. A full time Recreation Director develops, evaluates, and supervises over 50 adult and children recreation programs for the West Salem area. Our recreation programs are original, well received, and well attended by West Salem area residents. The variety of program choices is unique and numerous.

The Administration office provides all aspects of municipal government services, including, but not limited to: Real estate and personal property tax collection; licenses and permits issuing; election services; municipal accounting, budgeting, and financial planning; real and personal property assessments; contract services; building inspection and permit issuing; capital expenditures; debt service; and customer services and public relations.


Motion by Nicole Vidal, seconded by Jodie Curtis to adjourn the meeting at 12:24 p.m. Motion approved.
